- Buy candidate: Fury Gold Mines LTD (FURY)
- Industry Group: Mining-Gold/Silver/Gems industry group
- After getting a buy signal in the Mining-Gold/Silver/gems industry group on January 4, 2021, the group drifted lower for 5 weeks.
- This week Individual Stocks in the group are giving buy signals and institutional buying.
- FURY broke out of the high handle of a cup-with-handle base that started in October 2020.
- Buy when stock crosses 1.82 with volume.
- Start position at 3-star(***)
- Under massive accumulation with an Up/Down Volume ratio of 2.4.
- OGEN closed at 1.81. After hours it traded at 1.82.
- 1st target price: 2.46
- 2nd Target price between **3.19**.
 - Stop sell price: Close below 1.72.





- Buy candidate ARYA Sciences Acquisition Corporation III CL A (ARYA)/Nautilus Biotechnology
- ARYA announced a reverse merger with **Nautilus Biotechnology**, and we took a **95.26%** profit at our **20.23** target number.
- Industry Group: Blank Check/Special Purpose Acquisition Company (SPAC).
- Industry Group: Medical-Biotech
- With Biotech industry group red hot, we are looking to buy AYRA back after retracement to 17.60-16.77 target support area.
- Start position at 2-star(**)
- After merger announcement a SPAC typically pulls back before launching to new highs. Therefore, we take profits at our target number on the day of the merger announcement and look to buy back on retracement.
- Under massive accumulation with an Up/Down Volume ratio of 18.6
- Massive volume came in to push the stock higher on Monday.
- Buy AYRA on retracement to 17.60-16.77.
- Target price: **29.80.**
 - Stop sell price: Close below 14.72.

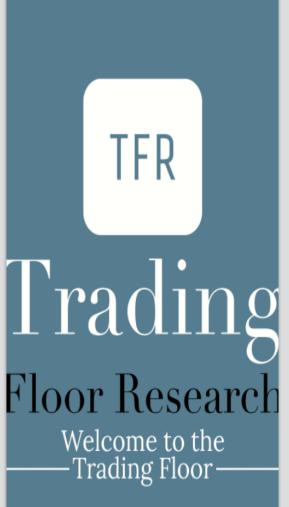




