

 Townsquare Media CL A (TSQ). A new buy candidate in the Media Radio/TV industry group.

- Buy candidate: **Townsquare Media CL A (TSQ)**
- Industry Group: Media Radio/TV industry group
- The Media Radio/Tv industry group is up 62.43% YTD and is the 3rd best performing industry group in the market. Stocks in the group like Discovery Inc. have already done very well.
- TSQ provides radio broadcasting services. The Company acquires, develops, and operates radio stations and digital properties in mid-sized markets. Townsquare Media owns FM and AM radio stations throughout the United States.
- Analyst' anticipate earnings growth of over 1000% in 2021 to \$1.14/share. Based on Monday's closing price of 11.89, TSQ is trading at **a P/E of 10x** this year's earnings estimates.
- TSQ is breaking out of a double bottom base with a handle.
- TSQ is trading in the upper half of its IPO base, and the bulls have taken control.
- Buy when TSQ gives a 30-minute buy signal with a 30-minute close above 12.07 with volume.
- Start position at 1-star(*) (Market concerns)
- Under heavy accumulation with an Up/Down Volume ratio of 1.9.
- Warning: Very thin float. Only 9 million shares in the float. Do not chase stock with market orders.
- TSQ closed at **11.89**. Buy between **12.07-12.67** (Do not pay more than **5%** above **12.07**)
- Sell target price: target 18.69

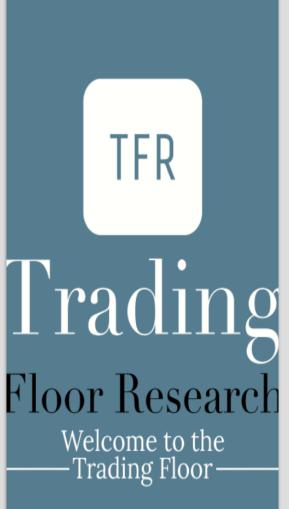
